It is a non-government, non-political and non-religious independent organization that operates under the guidance of a diverse group of community-minded volunteer Board of Directors. In 2005 the Act was amended and the title changed to Community Foundation of Medicine Hat & Southeastern Alberta.

# Welcoming Message...

It is very uplifting to hear the stories from organizations that have received funding and to learn about the impact these grants have made. It is clear that these organizations are able to advance their missions and make a difference for many local people.

The Foundation's donors have been outstanding in their generosity helping us to distribute nearly \$250,000 of grants in the past 12 months, which is a 13% increase over the prior year. This was particularly evident in the support provided to the Immediate Assistance Fund for Flood Relief. Nearly \$88,000 was raised and every cent went directly to those affected. Many thanks to the Municipalities who we worked with to establish the utilities rebate program which in most cases meant that those hit hardest by the flooding didn't have to pay a utility bill last winter.

The effects of the highs and lows on the global economy and the investment markets have had a tremendous impact on all types of organizations including community foundations. In the past year we have seen somewhat of a recovery as far as our investment portfolio is concerned although continuing market volatility is clearly here to stay for a while yet.

Recognizing the important leadership role that we play in the community, we are using this time to update: our strategies, the structure of our committees and the role of both Board and Staff. The Foundation can act as a catalyst for collaboration, partnerships and networking. We recognize the importance of programs such as Vital Signs® in demonstrating our in depth community knowledge and possible opportunities for community action.

This year we said farewell to retiring board members Sharran Kungel, Janice Blair, and Brian Rothwell. Thank you for everything you have done for the Community Foundation. To new board members Elaine Beierbach, Dennis Egert, and Jason Melhoff a warm welcome. To the organizations that turn grants into vital programs and generous donors who make it all possible, thank you. The Community Foundation is situated to continue to make a positive impact and to work towards our vision of *Creating a better community: Today, Tomorrow, Forever.*

# The Power of Endowment ...

Charles Harvey's parents taught him about the importance of giving back and, in 1991, Charles continued that tradition. He established the Charles F. J. Harvey Family Fund at his local community foundation.

His initial gift was \$15,000. But over the years Charles' fund grew, through new contributions and prudent stewardship of the capital, to \$278,000. Every year his fund provides \$14,000 in grants to youth-at-risk, or isolated seniors or programs that allow the physically challenged to work, live and play to their full potential.

Today, Charles' initial gift has been given away more than 18 times already.

His gift of \$15,000 could have been spent in 1991, with a single impact in the community. But compare that to the benefit the community continues to realize through the endowment of his gift. In another 15 or 30 or 45 years this story will still be relevant — it is not just a moment in history for Charles Harvey and his community... it is a growing legacy.

# Helping Neighbours

In the summer of 2010 the Community Foundation started accepting donations for the Flood Relief 2010 Fund, in support of those affected by the devastating flooding in Medicine Hat, Irvine, Cypress County and surrounding areas. Total donations received were \$82,559.00. Among the first to donate were the Medicine Hat Realtors Charitable Foundation. Very generous donations followed from local businesses, service clubs, churches and caring local citizens.

Mike Christie, Executive Director of the Community Foundation, stated "it was amazing to watch citizens band together and pool their many resources to assist those so desperately in need after the June flooding."

While several organizations took care of flood victims' immediate needs, the board of directors of the Community Foundation decided to focus assistance on the mid to long-term needs of flood victims.

A utility rebate program was created in partnership with the Cypress County and the

City of Medicine Hat. The \$61,385 received assisted 43 County residents while the City of Medicine Hat received \$9,100 for seven Medicine Hat residents who were heavily impacted by the flood. The intention was to help them get through the coldest part of the winter.

In addition local community group Kidsport received \$2,500 to provide five children the opportunity to participate in sports programs. Twenty Mile Post Historical Society accepted \$6,000 to go towards uninsured restoration costs which helped to keep the museum open. The Irvine Ag Society received \$3,574 for their generous support to Irvine during the worst part of the flood.

"We are very proud of the work we have done in Southeastern Alberta, beginning with that very first grant to the City of Medicine Hat for flood relief in 1995. This is why we are here" said Les Erikson, Community Foundation Board Chair (2010).

### The Financial Zimes...

The past year (the 12 months covered by this report) has certainly been one of the best in terms of performance that we have experienced. Simply put we achieved a 12.9% return on investment.

This is very good news and for the first time since 2007 we are back in the black. In other words most of the investment gains erased our negative position. To be clear that means that the market value of the investment portfolio has exceeded the contributed capital.


Part of this better result is due to the Foundation's discipline and rigour in setting policies and selection of investment manager. Certainly fluctuations in the markets are still with us and no doubt will continue for some time to come as the economy recovers. The Foundation will continue to carefully monitor the portfolio performance and adjust our strategies where necessary.


Grant making continued during 2010/2011 and returned to near normal levels. Details are




A sound local economy and a good tax environment are essential elements to maintaining a high level of charitable giving not only to the Community Foundation but to the local charitable sector. Gifts of securities are still one of the most tax efficient methods of giving and if you would like to learn about this contact your professional advisor or the Community Foundation. Changes to the Income Tax Act announced in March 2010 federal budget gave greater flexibility in how charitable gifts can be used. Term endowments are now possible. As an example a gift of \$10,000 for a scholarship of \$1,000 per year for the next ten years is now possible with the Community Foundation. 
#### 2010/2011 Administration Costs: \$269,256












#### **Total Donations by Year**



# Our grants at work: Roots of Empathy


As innocent and pure as a newborn baby always is, it can be easy to forget just how rapidly they absorb their surroundings from the moment of birth. If a child is born into a negative environment they begin to adjust in a negative way, whereas if a child is shown the right way to treat and love others right from that first day, the likelihood is they will grow up and act accordingly. That's where Roots of Empathy comes in. It is a classroom-based program that assists infants and children alike in learning empathy. Over the past six years, new parents in Medicine Hat have been

taking their babies into local schools and teaching children how babies respond to emotion.

"(This program) isn't there to teach anything to you parenting wise," says local Roots of Empathy representative Melanie Connellan. "It's actually teaching the baby. Essentially the whole thing is about improving empathy amongst kids, helping to reduce future issues like bullying and aggressive behaviour as they grow up." Connellan says the baby is also teaching the parent through this program. Because babies can only express their wants and needs through emotion, the baby needs to learn the best ways to do this, while the parent needs to learn what these different emotional signs really mean. Roots of Empathy also helps guide the parent and child toward non-aggressive responses to those feelings and to help create an early, unbreakable bond based on love and respect.

The Medicine Hat Roots of Empathy recently completed 15 programs within the region, including Brooks and Redcliff. In order to provide that broad a service, and to ensure each family is given a dedicated, qualified instructor, money is needed for training. Thanks to \$6,000 from the Community Foundation, Roots of Empathy was able totrain three new instructors, thus expanding the organization's capacity to provide its services.

"The entire amount from that grant went towards training instructors," says Connellan. "That really helped us to be sustained because we were kind of in limbo there. It just gave us that boost we really needed to move forward."



# Executive Directors' Active Virectors'

The lead staff person in a charity or not-forprofit (NFP) organization often holds the title of Executive Director. Although as many of us in that role discovered recently the position title may also be CEO, General Manager or President. For the purpose of this article I will use the title Executive Director or ED for all my lead staff colleagues.

EDs are very different people with a wide range of skills and experiences. For example, the ED at the Women's Shelter has a social work background; at the Stampede Company a background in the agriculture world is obviously needed, and the same could be said for the Library, Chamber of Commerce, Economic Development or any of the other nearly 30 organizations that operate locally with a full-time ED.

The environment in which an ED must function contains as much, if not more, regulation than a private or public organization. An ED operating in the so-called third sector is surrounded by such things as: the Income Tax Act, CRA Regulations, Charities Accounting Act, Charitable Fund-Raising Act, PIPEDA, Trustee Act, Societies Act, Corporation Act, and I could gone on, and all this is before considering regulations specific to the nature of business that the organization is involved in.

So having satisfied the legal framework, the ED must then ensure the organization has everything it needs to function. Recruiting good quality staff and somehow retaining them is always high on the agenda. However, for many, recruit-

ing and retaining volunteers is equally important and that includes Board Members and learning to work with a diverse group of people who are tasked with policy and strategy that the ED must then implement. So other items on the "to do list" include budgets, accounting, audit, insurance, computers and other information technology, marketing, grants and fundraising.

These are the type of issues that are common to all EDs and why the Community Foundation saw an opportunity to create a local ED Network. The membership is restricted to EDs in full time positions, who employ staff and who report to an independent board of directors. The concept is to have a safe place for EDs to share best practice and discuss issues that are common to everyone and learn from each other.

The ED Network first met just over a year ago. It was decided meetings two or three times a year would be sufficient to serve the purpose. I chaired the first meeting and as my ED colleagues arrived I realized that while I knew them all, they did not know each other. The meeting went well and as a group established the topics for discussion. As we concluded, I noticed two EDs are talking privately and agreeing on a joint partnership for an upcoming event. This is clear evidence to me of the value of networking or building social capital. The network has now met several times and like other similar professional networking groups will continue to assist EDs to operate in the regulatory quagmire and reduce the size of the dreaded "to do list"!

## **Vital**Signs®

This year marked the fifth anniversary of Vital Signs in Medicine Hat. On October 4th Vital Signs was released nationally in 22 different communities. Each of these report cards is community specific and expanded on 11 issue areas from Health to the Gap between Rich and Poor to the Environment. Nationally there was a focus on many indicators including obesity and high school completion rates. Locally, the number of people considered homeless or at risk of homelessness was shocking to many.

Vital Sigsn is a tool that many community leaders and business people have come to rely on for information about Medicine Hat. Special to the fifth edition was its focus on the trends over the years using indicators from past reports. After five years we are able to see where we have been, how we are currently addressing key issues and where we are headed.

Vital Signs is more than a publication for the Foundation. The report allows us to understand the hot points in the community, allowing us to identify areas in which to focus our leadership role and grant making process. We take this publication very seriously and require grant applicants to indicate how their project will address issues in current and past reports.

As an extension of Vital Signs, the Foundation has created Vital Activity. Included in Vital Activ-

ity are Vital Munch and Vital Kids. Each of these programs take indicators discovered within Vital Signs and allowing members of the community to discuss these issues with concerned experts. For Vital Kids the Foundation staff takes Vital Signs to the classroom and discusses with students what is happening in the community.

The Foundation is very proud of the Vital Signs initiative and the leadership role it plays within the community. This year we were pleased to partner with Jim Pattison Broadcast Group on a series of clips aired on Chat TV. These clips included information about smoking, spit tobacco and healthy eating.
