#### **DONOR STORY: ALEXANDER MCDOUGALD**



Alex and Jean McDougald

"Alex was an energetic person who had a wide range of interests. There was always something on the go. Including others and making new friends along the way came naturally to him." – John McDougald, nephew

Alexander "Alex" Paul McDougald was born in Maple Creek, Saskatchewan on January 8, 1929. He was the youngest of three boys, born to James and Florence (Cumberland) McDougald. Alex and his brother Jack, ranched together south of Maple Creek until 1965 when Jack purchased Alex's share of the ranch. At that time, Alex purchased the Augie Sauer Ranch south of Suffield and established McDougald Livestock Ltd.

Alex married Jean Forbes on October 3, 1976, and they lived on the ranch until 1988. In 1998, Alex sold half the ranch to John McDougald (nephew) and half to Gordon Forbes (Jean's son). John established his half as Park Livestock, while Gordon operates as Cottonwood Livestock.

Alexander was driven by physical fitness and was an active and dedicated member of the Medicine Hat YMCA for over 20 years. He enjoyed volunteering for the Special Olympics as a swim coach and was a serious cyclist with many years of tours covering thousands of kilometres. Alex and Jean enjoyed many winter trips to Surprise, Arizona to escape the Alberta winter. The McDougalds were very social and were often the hosts to many social gatherings.

In 1997, the Alex and Jean McDougald Fund was established at the Community Foundation of Southeastern Alberta. Alexander's philanthropic journey guided him to launch two of his initial legacy projects in support of the Maple Creek Skating Rink and the SW Saskatchewan Oldtimers' Museum in the early 2000's. Alexander passed away in 2010 which inspired Jean to establish the Alex McDougald Memorial Fund which annually contributes to the Smart and Caring Community Fund.

Alex became a Heritage Club member in 2009, making a conscious decision to build today into a better tomorrow. The Community Foundation of Southeastern Alberta is extremely grateful for Alexander's bequest of \$2.8 million. Alexander and Jean will live in the hearts of many, and our community will feel their presence forever from the kindness, generosity, and impact of their legacy.

# COMMUNITY IMPACT AWARD

The Community Impact Award is a **\$25,000** grant designed for agencies with innovative project ideas that show creativity and leadership in supporting vibrant, healthy, and caring communities.

\$25,000 was awarded to a partnership consisting of the Cypress View Foundation and Bike Medicine Hat in support of the new chapter of Cycling Without Age. Cycling Without Age helps to alleviate isolation, and physical & mental health challenges of the senior & disabled population living in care facilities. This grant will assist in purchasing two trishaw electric bikes (piloted by youth & adult volunteers) that will allow riders to experience bike riding, nature, their community, and to reconnect safely with their family and friends.

### **CANADA HEALTHY COMMUNITIES INITIATIVE (CHCI)**

The Healthy Communities Initiative is a \$31 million investment from the Government of Canada to support communities as they create and adapt public spaces to respond to the new realities of COVID-19. We are proud to be working with Community Foundations of Canada and the Government of Canada alongside other Community Foundations across Southern Alberta to provide \$1,267,320 of funding to support organizations who are showing creativity and resourcefulness in creating solutions that enable people to connect and access public spaces safely while still respecting public health measures.

The second round of the Healthy Communities Initiative opened on May 14. The CHCI is funding projects between \$5,000 and \$250,000 that help create **safe and vibrant public spaces**, **improve mobility options**, and provide **digital solutions** to help their neighbourhoods or communities navigate the pandemic and look to build back better in the COVID-19 recovery. A variety of community-led organizations have been eligible to apply, including local governments, charities, Indigenous communities, and registered non-profit organizations.

A total of 14 groups across Southern Alberta were recipients in round one of the Canada Healthy Communities Initiative. *Congratulations* to two organizations from the Southeastern Alberta region for their successful submissions.

#### **ADVISOR MANAGED ENDOWMENT FUND**

When you make a donation to the Community Foundation of Southeastern Alberta, it is never spent. It is invested into an endowment with Community Foundation's professional wealth advisor. The investment earnings from those donations are the funds we grant back out into our community, supporting local agencies across Southeast Alberta, today, tomorrow, forever.

For the first time at CFSEA, donors are now able to work with the Community Foundation and their investment advisor to build a stronger community. **Advisor Managed Endowment Funds** allow donors to maintain the trusted relationship with their investment advisor while creating a platform to accomplish their philanthropic wishes.

#### How it Works...

Together with their financial advisor, donors may choose their portfolio makeup, within the guidelines stipulated by the Community Foundation and other terms within the Investment Advisor Agreement.

The Community Foundation will be the owner and only beneficiary of the portfolio as is required by Canada Revenue Agency to comply with the Community Foundation's ability to provide a charitable receipt for stock contributions.
